

Health Hires: Vt. SG To Stris, BCBS In-House To Kilpatrick

Law360, New York (April 7, 2017, 4:13 PM EDT) -- Stris & Maher LLP has opened a Vermont office led by two of the state's top attorneys; in-house counsel at Blue Cross and Blue Shield of North Carolina has rejoined Kilpatrick Townsend & Stockton LLP; Maxor National Pharmacy Services LLC has named a new general counsel; Hinckley Allen & Snyder LLP has a new health care partner from Brown Rudnick LLP; and Cozen O'Connor has brought on a government relations professional focused on health care policy.

Stris & Maher Opens Vt. Office With Top State Gov't Attys

Bridget Asay, who was Vermont's first solicitor general, and Mike Donofrio, former general counsel for the state's Green Mountain Care Board, have launched Stris & Maher's new office in Montpelier, Vermont.

The new partners, who will focus on complex health care litigation, had first worked with Stris & Maher when the firm represented Vermont in *Gobeille v. Liberty Mutual Insurance Co.*, a U.S. Supreme Court appeal they ultimately lost in March 2016. The court had decided that the Employee Retirement Income Security Act's reporting requirements trump those of individual states, including a Vermont requirement that self-insured employee health plans must report claims data.

But during that effort, Asay and Donofrio found the firm "to be responsive, creative, and smart," Asay said in a statement. "They added tremendous value to our efforts in *Gobeille*, and they were great colleagues throughout the process."

Asay, a graduate of Yale Law School, was appointed solicitor general in 2015. Before that, she had spent more than a decade supervising all of the Vermont Attorney General Office's appellate litigation. This led to two appearances before the U.S. Supreme Court and more than 40 before the Vermont Supreme Court, Stris & Maher said.

Donofrio, a New York University School of Law graduate, spent four years as the first general counsel of a regulatory body meant to reduce

the cost of health care in the state. The Green Mountain Care Board had been formed as part of a 2011 health care reform law. Before that, he taught at Brooklyn Law School and worked on complex civil and white-collar litigation at Holland & Knight LLP and what's now Wachtel Missry LLP.

BCBS of North Carolina Atty Rejoins Kilpatrick Townsend

Chad Hansen is leaving his role as in-house counsel at Blue Cross and Blue Shield of North Carolina to rejoin Kilpatrick Townsend in Winston-Salem, North Carolina, focusing on litigation and health care.

As a partner in the complex commercial litigation team, Hansen will work on cases involving health care, ERISA, class actions, product liability, trade secrets and intellectual property, among other areas.
